### Suggested Specification

Model F120 is a non-refrigerated drinking fountain for direct connection to a cold water supply or for use with remote water chillers. Cabinet finish shall be brushed stainless steel. Shall comply with ANSI 117.1. Shall be listed by Underwriters Laboratories to US and Canadian standards. Shall comply with ANSI/NSF 61 and NSF/ANSI 372.

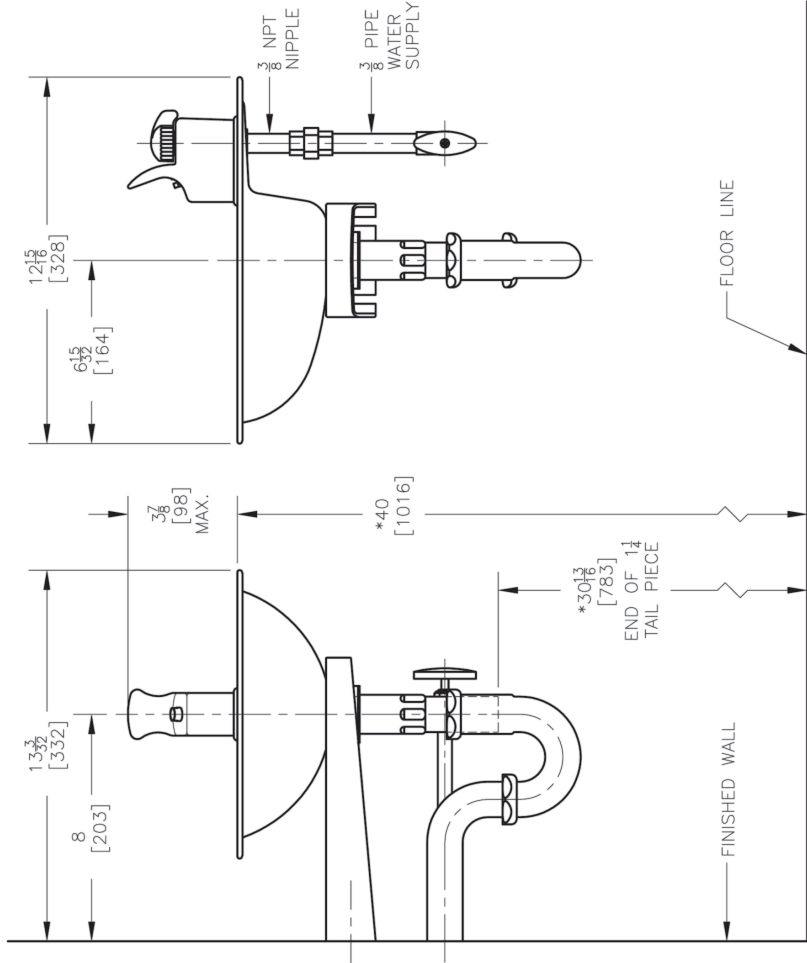

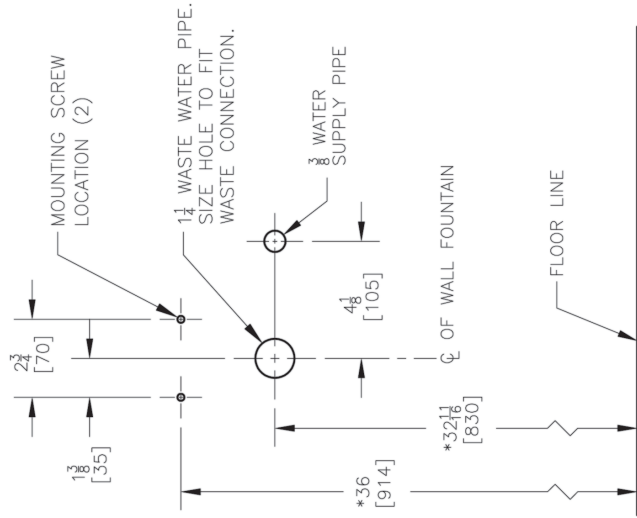

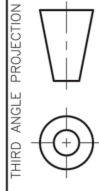


ROUGHING-IN DRAWING
