- ❑ Valve Repair Kit For 5010: Model VRK5010, valve repair kit that includes the cartridge assembly, screen and washer.

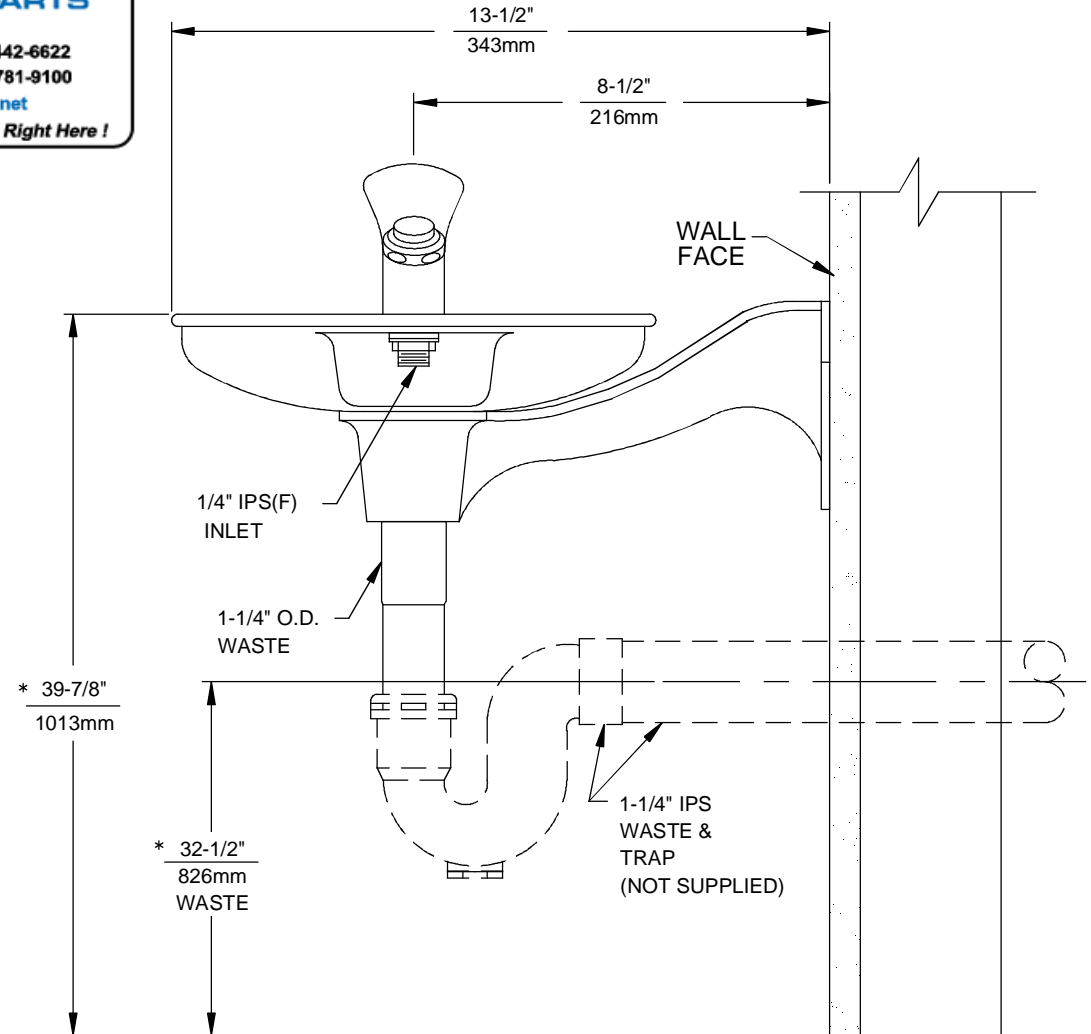
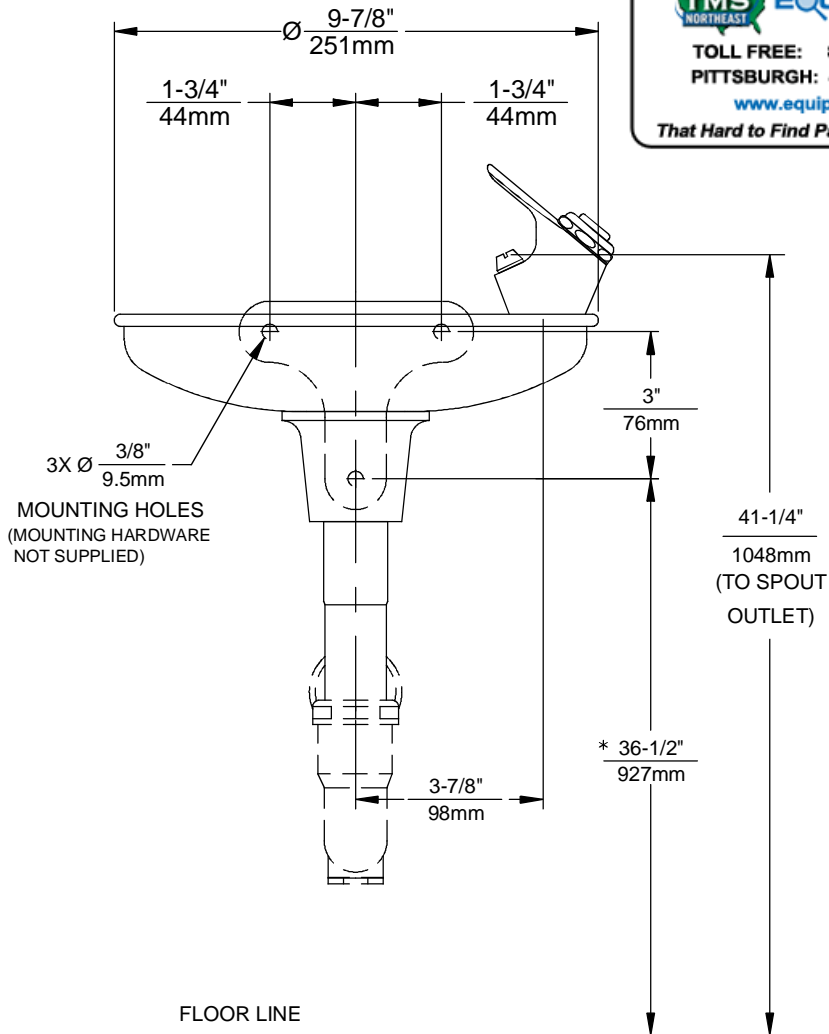
SPECIFICATIONS

Model 1152 wall mounted drinking fountain shall include a polished stainless steel round basin, polished stainless steel push-button bubbler valve with flow adjustment, anodized cast-aluminum wall bracket, 100% lead-free waterways, and chrome-plated 1-1/4" O.D. tailpiece.

APPLICATIONS

Perfect for either public or private settings, Model 1152 drinking fountain is great for those looking to obtain a full functioning fountain with a simplistic design. Unit fits nicely into campground settings and other environments that are in more remote areas where drinking fountain facilities are still needed. Corrosion resistant stainless steel bowl and push button valve with adjustable stream makes for just the right combination of protection and adjustability needed in a basic fountain. Haws manufactures drinking fountains, faucets and electric water coolers to be lead-free by all known definitions including NSF/ANSI/CAN 61-Section 9, NSF/ANSI/CAN 372, California Proposition 65, and the Federal Safe Drinking Water Act.
